
MISSION

This Organization was established in 2014 in memory of Dr.Vimi who was my dear student. Her batch mates '21st Flemings' who are a group of humanitarians and eminent doctors in their respective fields came up with idea of such a centre with thorough support of Vimi's family members. The Society, from 05/03/2017, is running a permanent programme by the name ``DR.VIMI MEMORIAL CEREBRAL PALSY GUIDANCE CENTRE`` for the well-being of the differently abled children.

The services and general functioning of the Society during the reported year 2018-19 were carried on smoothly without any hindrance whatsoever.

Several differently abled children & families had experienced the services of our CP guidance Centre. Certain new equipments were procured for the Centre. But for the unprecedented heavy showers creating flood in August 2018 which badly affected the Centre.

Special mention is added to express affectionate thanks to Dr.Aswinkumar & Dr.Nithya who despite their official responsibilities, had offered their valuable services on all 3rd Wednesdays of every month for the children of our Cerebral Palsy Guidance Centre.













UPCOMING DEVELOPMENT PLANS:

Certain parents are of the opinion that a Special Teacher has to be appointed in the Centre so that they can entrust the children here and engage in petty household jobs and collect their children in the evening. It is felt that their suggestion is genuine.

Due to scarcity of ample space in the present rented building, the Centre finds it difficult to accept more incumbents seeking suitable service. As such an alternate housing has to be located at the earliest at moderate rentals.


